Vendor Space Fee Schedule

10'x10' space for a full year (13-15 markets) - \$100.00

10'x 10' space for half a year (7 markets) - \$60.00

10'x 10' space per week (1 market) - \$10.00

The Market runs from 2-6pm every Friday from the first Friday in July to the final Friday in September – rain or shine due to our new location. Vendors may arrive as early as 12:30 pm the day of the market to set up, and MUST be ready to sell by the time the market opens at 2pm. Spaces are 10'x10' and are available on a full season, half season, OR weekly basis. This form must be completed regardless of whether the vendor's participation preferences (full season, weekly, etc).

All vendors must provide a Certificate of Insurance with a liability limit of no less than \$1 million and shall name the Cuba Farmers' and Artisans' Market and the Cuba Cultural Center, Inc. as additionally insured.

Each vendor is responsible for their own property, the Cuba Farmers' and Artisans' Market and the Cuba Cultural Center, Inc. are not responsible for any damage, theft, or loss for any reason.

The Cuba Farmers' and Artisans' Market is unable to provide electrical and/or water hook up for vendors. All vendors must bring the necessary equipment with them to furnish their own unique needs.

I agree to the terms and conditions outlined in this form and the Market Manual. I understand the rules and regulations and will abide by the rules and regulations of the Market.
